ORDER

1. Provisional affiliation was granted for starting B.Ed. programme with an intake of 100 students at Sree Swami Vivekananda Centre of Teacher Education (Un-Aided), Mayilumpuram, Ottappalam, Palakkad during the academic year 2004-05, vide U.O. read as (1).
2. As per National Council for Teacher Education (NCTE) Regulations, 2014, the B.Ed. programme shall be of a duration of two academic years, and the intake shall be a basic unit of 50 students, with a maximum of two units. The NCTE permitted the College for conducting B.Ed. programme of 2 years duration with an annual intake of 50 students (one basic unit) w.e.f. the academic session 2015-16, vide paper read as (2).
3. Permission was granted to consider the applications received from the training colleges at the beginning of each academic year as in the case of other courses and grant Continuation of Provisional Affiliation, without insisting orders for extension of approval from the NCTE, vide U.O. read as (3).
4. A revised seat distribution of B.Ed. seats w.e.f. academic year 2020-'21 and re-arrangement of seats for academic year 2020-'21 was sanctioned at the College, vide U.O. read as (4).
5. Continuation of Provisional Affiliation to B.Ed. programme for academic year 2023-'24 and re-arrangement of seats among optional subjects for 2023-'25 batch was granted conditionally, subject to submission of renewed NOC from Government, vide U.O. read as (5). Principal has submitted renewed NOC for the academic year 2023-'24, vide G.O. read as (6).
6. The Principal has submitted application for Continuation of Provisional Affiliation to the self financing B.Ed. programme for the academic year 2024-'25, vide paper read as (8) with renewed NOC for 2024-'25, vide G.O. read as (9).
7. Considering the matter in detail, sanction has been accorded by the Vice Chancellor
 - (i) to grant Continuation of Provisional Affiliation to the self financing B.Ed. programme with an intake of 50 students (50 x 1 unit) at Sree Swamy Vivekananda Centre of Teacher Education (Un-Aided), Mayilumpuram, Ottappalam, Palakkad for the academic year 2024-25, as detailed below, and:
 - (ii) to absolutize the U.O.No. 4752/2023/Admn dated 15.03.2023 granting Continuation of Provisional Affiliation to the B.Ed. programme during the academic year 2023-'24, since the college has produced the

8. Orders are issued accordingly subject to the following terms and conditions:

- i. The Principal shall strictly follow the syllabi, available on the University website (www.uoc.ac.in) for selecting complementary courses..
- ii. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- iii. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take stringent measures for the prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv. Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- v. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders,
- vi. The conduct of University Examinations of any sort including that of the SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- vii. The college is liable to comply with the general conditions stipulated in the renewed NOC from the Government of Kerala for the academic year.
- viii. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- ix. Violation of any of the above will lead to the cancellation of affiliation.
